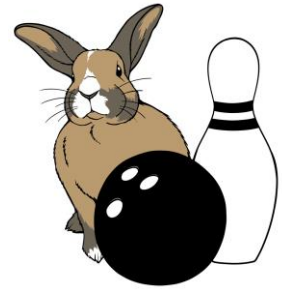

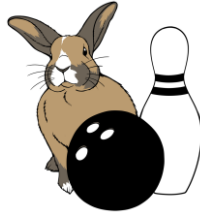
We are also seeking t-shirt sponsors for this event at \$100 per sponsor.
